Facility Types and Descriptions

Observation and Assessment (O&A)

Observation and assessment provides comprehensive evaluations and treatment planning. Youths receive extensive psychological, behavioral, social, educational, and physical assessments to identify their needs for services.

A 45-day residential program for delinquent youths placed in the custody of JJS for evaluation, assessment, and treatment planning.

Secure Facilities (Long Term and Detention)

Long Term Secure Care – Locked confinement facilities for youths who are in need of services for serious and habitual delinquency.

Detention – Locked confinement facilities for youths who are in need of early intervention services.

Work Camps

Work camps are non-secure residential placements that require delinquent youth to do physical labor. The key objective is to hold delinquent youth accountable for their behavior and help them to meet court-ordered obligations to perform community service and pay back victims for the damages they caused.
